SCHOOL POLICY

St. Mary's School makes every effort to keep tuition rates affordable. The cost of educating a student is over \$9,000. The difference between the actual cost and tuition paid is made up by **your participation** in fundraisers and SCRIP, gifts and donations, along with a generous support by St. Mary's Parish.

St. Mary's School is as dependent on parent participation as it is on finances. Opportunities for involvement are provided through PALS (Parents Organization), Committees (School Council, Finance, Development, Facilities, etc.), and Classroom Aides are a few which satisfy this obligation.

TUITION & FEES

A \$250 non-refundable registration fee PER CHILD is required. Tuition payments are due according to the Tuition Plan you select.

_____ Two payments (due: August 10, 2010; February 10, 2011)

_____ Quarterly payments (due: August 10, 2010, November 10, 2010; February 10, 2011; May 10, 2011).

_____ Ten (10) monthly payments (due: August 10, 2010 through May 10, 2011)

TUITION PAYMENT OPTIONS: Payment may be made by either cash or check. A \$10 fee will be charged for late tuition. Contact office concerning late fees.

TUITION RATES:

It is understood that the undersigned parents or guardians acknowledge that if any payment or commitment due under this contract is not made on the date due, one or more of the following will occur:

- A. The payment of the entire sum of the past due, then due and unpaid under this agreement, shall be accelerated, and without notice demand the full amount to be paid under this contract shall be immediately due and payable.
- B. The child or children will not be admitted to class until the amounts due are paid.
- C. Final Report card will be held until all financial obligations are completed.

SCRIP

The annual SCRIP obligation is \$4,000 per family, from July 1, 2010 through June 30, 2011. An unfulfilled SCRIP obligation will be billed at 5% of the balance due in the May 2011 billing.

PARENT PARTICIPATION

We request a minimum of 25 hours per family (at least half must be performed in conjunction with PALS fundraisers), per school year for parent participation hours to support our school.

Scholarship

Scholarship is available based on need and determined by the Scholarship Committee and the availability of funds. Applications are available in the school office. Complete applications with current tax return and other pertinent information by May 14, 2010.
